New Price Ceiling For Petroleum Products on the Liberian Market Effective 4th April 2017

The Ministry of Commerce and Industry, in close consultation with the management of the Liberia Petroleum Refining Company, (LPRC), has announced that there will be a thirteen United States Cents (0.13¢) decrease in the price of gasoline (PMS) and eleven United States Cents (0.11¢) decrease in the price of fuel oil (AGO).

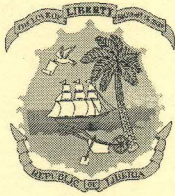
Note: The Exchange Rate (US\$1 – LRD\$106) used was based on the end-of-monthly exchange rate communicated directly by the Central Bank of Liberia



New Price Ceiling For Petroleum Product Heavy Fuel Oil (HFO) on the Liberian Market Effective 4th April 2017


The Ministry of Commerce and Industry, in close consultation with the management of the Liberia Petroleum Refining Company, (LPRC), has announced that there will be a US\$23.85 downward adjustment in the metric ton price of Heavy Fuel Oil as under:
